

#### **Overview of the Organization:**

#### Introduction:

Rastriya Dalit Network (RDN) Nepal is the national level Dalit organization working in the field of Dalit rights, land rights, Haliya rights, Kamaiya rights and Human Rights through community mobilization, capacity building and advocacy campaigns since the time of its establishment. It is working all over the country in 77 Districts. It has one Dalit activist in each district and 7 provincial chapters formed and functional.

RDN Nepal is registered as a non-governmental organization in District Administration Office, Kailali and affiliated in Social Welfare Council in 2003 AD. It organizes the General Assembly each year and election in each three years through democratic practice. It has regular audit and social audit from the very beginning.RDN Nepal has been working on human rights and social justice to end impunity, deprivation through human rights based to development.

There are 17 members in executive committee board. Out of them, more than 40% represents from women. A total 12 members (5 from key position and 7 from each province) are directly elected from its general assembly and rest 5 are nominated form various sectors (1 from Badi, one from freed Haliyas, one from elected Dalit representatives and 2 from women).

**Vision**: A just society without caste based untouchability and discrimination as recognized by the universal principles.

**Mission:** To play a lead role in establishing a human rights-oriented resource centre for Dalit's identity, representation and access.

**Goal:** To influence in the decision making level for guarantying political, economic, social and cultural rights by way of elimination of caste based untouchability and discrimination

#### Objective (s):

- To conduct evidence based advocacy campaigns for the effective implementation of the constitutional provisions of Nepal and other prevailing laws relating to Dalit Rights.
- To influence the laws in line with the treaties and agreements relating to human rights and elimination of all forms of discriminations and slavery to which Nepal is a party and other commitment and to implement them as a law pursuant to Nepal.
- To carry-out study, action research and organize meetings, conferences as well as mobilization of Dalits for their rights for symbolic alternative events, trainings, campaigns, and public awareness programs on different issues in relation to elimination of all kinds of discrimination and slavery.
- To perform other related functions to attain the goal and objectives of the organization respectively
- To promote the income generation of Dalits, women, land-poor and other marginalized groups through cooperative led livelihood options and food security

#### Situation Analysis:

Target groups Kamaiyas at Kailali districts are still homeless in safe-shelter prospective due to the insufficient rehabilitation of the government. As per the survey conducted by the LWF Nepal in 2014, a total of 72.9% of freed Kamaiya don't have access on forest and forest products. Likely, relating to health services 81.3% freed Kamaiyas don't have access on those services. Similarly, 62% of ex-Kamaiya communities are still deprived from their participation in any decisions affecting them. The research study-2021 on socio-economic status of Dalits conducted by RDN with the financial support of The Asia Foundation shows that as high as 80% of them live either in tiled roof houses or temporary houses. Only 19% of the HHs had permanent (pakki) house. Likewise, vulnerability to food insecurity exists to nearly 77.6% of the HHs. The issue of landless households is a long standing problem of Dalits at Kailali district. The study shows that 57% of Dalit HHs own some land but do not possess land ownership certificate (lalpurja).

#### **Project Background:**

Rastriya Dalit Network (RDN) has been implementing SurakshitAawashproject in Kailali and Kanchanpur districtsince May 1<sup>st</sup> 2022 to Dec 2022. Under the project, landless, dalit, exbonded labors, badi, flood affected and vulnerable families living in substandard condition are being targeted to serve safer shelter.

The project also includes support in process to the local government for joint land title under land commission in working district. Besides some activities are also being carried out for WASH awareness, DR3 community enhancement and youth mobilization.

Target Groups: Target groups and beneficiaries; ex-Kamaiyas, Dalits and Badi including other vulnerable groups at Kailali and Kanchanpur district

#### Rationale of Target:

The rationale for selecting the target beneficiaries; ex-Kamaiyas, Dalits and Badi including other vulnerable groups for supporting in the area of safe housing are mentioned below;

- Freed Haliya, ex-Kamaiya and Harawa-Charawa situation study committee recently formed by federal ministry of land reform, cooperative and poverty alleviation recommended that the 3 layers of government (local, province and federal) needs to take immediate action for safe housing of ex-Kamaiys for their resilient livelihood options
- The newly promulgated constitution-2015 has significant provisions for the rights of very poor and oppressed. Land and housing issues are considered as fundamental rights. The article-40 (5 and 6) has ensured the land and housing rights of Dalits.







- It is observed that ex-bonded agriculture laborers (Haliyas and Kamaiyas), ex-sex workers (Badis) and other marginalized and vulnerable groups have need of housing support
- The target beneficiaries; laborers (Haliyas and Kamaiyas), ex-sex workers (Badis) and other marginalized and vulnerable groups are compelled to dwell their life in poverty in poor shacks in public/government owned land.

#### **Project Activities:**

In order to achieve the anticipated objectives of the proposed project, the project activities have been set out linking with the supporting area and priority of Habitat for Humanity Nepal including its West strategies working with poor and oppressed groups. The activities under each objective implementation model are designed based upon the past learning and best practices of Rastriya Dalit Network (RDN) Nepal from similar experience and expertise. The implementation process and minimum standard for each activity has been further detailed-out by developing detail implementation plan (DIP) as outlined below:

#### A. Social Mobilization:

#### 1.1 Baseline Survey

**Objective:** To collect the basic information of households after new sites are identified. Based on format provided by the MEAL department, field staffs, social mobilizers will be mobilized and collect the data to fill online system.

#### Location and time:

The Baseline Survey will be conducted throughout the project period in both Kailali and Kanchanpur. At least three sites will be identified and finalized after the consultation of local and provincial government.

#### 1.3 Construction committee formation, orientation and mobilization







**Objective:**Construction of user committee formation, orientation and mobilizations aims to enhance accountability of families, communities and beneficiaries who will be directly benefited from the safe shelter. The construction activities are needed to carry on with leading of user committee that will have been developed where the sites of construction are finalized.

Following process will be adapted.

#### **User committee Formation:**

- Finalize the communities and families within the municipality which have shown the willingness and commit for the resource of house construction.
- Once the MoU with the government (LG or Provincial) government signed, initial discussion meeting will be organized in the communities and let them know why the communities and families are selected.
- Formation of user committee comprising both women, man and youth but mandatory representation of house owner to be.
- Minute and formal letter of user committee to be sent to the respective funding stakeholders

#### Requirement for User Committee

- Permanent member of the selected community and applicable of same services.
- Inclusive having proportionate number of men and women.
- Decisions must be participatory.
- List of requirements of UCG Committee.
- Active and trustworthy members should be selected who will carry out the responsibilities well under the project's ethics and regulation.
- No political influences or involvement.
- Able to motivate and encourage families and community.
- Gender sensitized.
- No connection with criminal activities such as fraud, theft, child abuse or trafficking.

#### **User committee Orientation&Mobilization:**

- Once the committee is formed, at first half day induction orientation will be organized about their roles and responsibilities.
- During the project period, they must have hold periodic meetings in a half month however encourage to organize meeting as per needs as well.
- Participation, procurement process, record keeping, safety measurement, family mobilization will be the key agendas of the meeting
- SM will facilitate the meeting however secretary is core responsible to lead the meetings.

#### **B.** Land Advocacy:

# 1.1 Support Government to provide joint land title (Land Ownership Certificate) to land less families

#### **Operational Context:**

The article of new constitution (40 of (5) and (6) has provisioned the land to landless Dalits community. The Universal Declaration of Human Rights (UDHR) has pointed-out the housing rights as fundamental human rights. Although, there are legal and constitutional provisions, but still it is not being implemented after 5 years of promulgation of the constitution. In addition, the government of Nepal has revised its land policy (8<sup>th</sup> revision) that has prioritized Dalit community. The major challenges are as to; the political parties and duty bears do not have willing power to implement the land policy in practice and they do not have also proper monitoring mechanism. Target beneficiaries; ex-Kamaiyas, Dalits and Badi including other vulnerable groups who are discriminated for a long time are poorly aware of their rights and claiming procedure and mechanisms, lack information and not well organized, and isolated.







#### Objective:

• To organize, empower and mobilize the target beneficiaries; ex-Kamaiyas, Dalits and Badi including other vulnerable groups to systematically claim for joint land title (land ownership certificate).

#### **Process:**

- Formation and strengthen right holders group at community level
- Coordination and collaboration with local government bodies and land commission
- Mobilization of the federation of dalits and Dalit community for the land advocacy
- Conduct regular interaction programs with land commission, local government and key dalit right activists on the land issues
- Conduct frequent monitoring visits on land distribution process of government
- Conduct synergy meetings with national land commission

#### C. Construction Assistance

#### 1.1 Construction of New Houses

**Objective:** To provide safe shelter to the most vulnerable families. All houses to be constructed under SurakshitAawash Project shall meet the applicable local codes and the HFHI Housing Quality Standards (HQS) that include standards for design, durability, secure tenure, water, and sanitation. In order to increase resilience to future disasters, risk management is a key component of site selection and house design.

#### **Bases of Family Selection:**

The GoN has existing criteria that provide an initial list of people considered vulnerable (e.g., elderly, disabled, orphans, single headed households, marginalized groups). All SurakshitAawash projects have additional supporting criteria so that the most vulnerable amongst this wider population are targeted for housing support.

The priority groups from which future homeowners are selected are those:

- Dalit caste and other marginalized ethnicities
- GoN identifies as disadvantaged
- Low-income criteria who are not able to construct a safe house
- who have their own land but live in inadequate, unsafe shelter.
- living in disaster-prone and vulnerable locations
- who are landless or living on community land in inadequate, unsafe shelter.
- living in locations with high-risk of forced evacuation (adjoining forests, along roadsides)
- displaced by disaster
- Dependent and disabled

#### Implementing Modality:

- Orient to government agencies about low cost and safe shelter structure and working process and disaster resilient.
- Soundly regular coordination with Government agencies and other stake holder for timely completion of construction activities.
- Closely rapid built with Municipality team members and other agencies for timely implementation safe shelter.







- User Committee is formed from the families in presence of the local government, Habitat Nepal, RDN and oriented them.
- Technical team from Habitat Nepal supervises the RDN technical team and user committee in market development part by supervising in material procurement. The team assist to select quality materials at reasonable market price.
- RDN technical team will get support/guidance from Habitat Nepal Technical team andis responsible in-house construction implementation from plot layout, day to day construction at field till house completion.
- RDN field team will mobilize Local masons by providing masonry skills to construct disaster resilient houses with the support of Habitat Nepal Technical team. The masons are closely guided by the team during the construction.
- RDN social mobilization team is encouraging families for their participation in house construction. The team has been facilitating with families for their 20% contribution in the form of labor contribution.

### 1.2 Support for finishing of ongoing project (provincial government partnership)

**Background:** As MoU signed between Ministry of Land Management Agriculture and Cooperative of Sudurpaschhim Province and Habitat For Humanity International (HFHN), there are a total of 50 houses have been constructing at Raji Community in Bhajani-09, Bhuruwa Kailali, and in Bedkot-5, Dharampur, Kanchanpur with coordination of respective local governments under MUKHYAMANTRI EKIKRIT BASTI BIKASH SAHAYOG KARYAKRAM for those highly marginalized, vulnerable group such as Haliya, Dalit, Raji, Badi, Landless, Vulnerable and Socially Excluded living in unsafe land and poor housing condition.

#### Objective:

As there is fluctuation in estimation of Bhajani and Bedkot construction site as consultant have reduce and remove many items like wall thickness at foundation, number of door and window etc during tendering. And contractor have also added Gabion wall at roof which were not included at estimation and drawing. Due to which contractor are not able to maintain basic requirement of houses at roofing and are not able to finish the construction at time, support in finishing is required to maintain quality and finishing.

The total estimation including steel plate fitting connection at roof, door fitting, toilet completion of 50 houses are Rs, 320994.9(detail at excel sheet attached). Out of total estimate, NPR 200000 is allowable for top up under the project.

#### **Staff Mobilization Plan:**

Overall programmatic and financial arrangement of "**SURAKISHIT AAWAS PROJECT**" will be managed by RDN Nepal with the technical and financial support of Habitat for Humanity Nepal. For the effective management of overall program, Project Management Team (PMT) will review and guide project team. The name of the project staffs and their key responsibilities are outlined as below;

- Mr. Hukum Bdr. Sarki, Executive Director of RDN will be responsible for overall projects management, fund rising as well as establish M&E system. However, you will be fully responsible-100% for planning, implementation, monitoring and reporting of SURAKISHIT AAWAS PROJECT. His contract shall come into force with effective from 1<sup>st</sup> June, 2022 and end on 31<sup>st</sup> December, 2022.
- Mr. Bharar Aagri, Admin and Finance Manager of RDN will be responsible for overall financial documentation and accounting of the project transactions, financial reporting of project funds, tracking of budget in line with activities and strategic support. However, you will be fully responsible-100% for financial management of SURAKISHIT AAWAS PROJECT. His contract shall come into force with effective from 1<sup>st</sup> May, 2022 and end on 31<sup>st</sup> December, 2022.
- **Mr. Mahadev Jaishi, sub-engineer** of the project will support in estimate, design and provide technical support in the construction of schemes; safe housing including toilet.
- Similarly, Ms. Anita Shrestha and Mr. Lal Bahadur Dangaura Tharu, social mobilizers of the project will have responsibilities to support and facilitate community level activity implementation and overall social mobilization in the project targeted area.

#### **Overall Project Implementation Strategies and Approaches:**

The project will adopt both rights based and need based approach for transferring the resource tapping capacities to target beneficiaries with constructive engagement of local, provincial and federal government. Particularly, the project will carry-out the following implementation strategies/approaches as mentioned as;

- Community Empowerment and Human Rights Based Approach: Project will adopt human rights based approach to development that empowers target communities to systematically claim for their rights and entitlements.
- Gender Equality and Social Inclusion (GESI) Mainstreaming: This project will ensure the equal participation of all sections (caste/sex/ethnicity) of the community to bring about sustainable changes in the households and societies, contributing in GESI. Minimum 50% women participants will be ensured in project planning and implementation.







- Coordination and Collaboration: The action will employ strategies to coordinate and collaborate with concerned government agencies. It will also coordinate with civil society organizations to avoid duplication and generate synergetic impacts.
- Accountability and Transparency: RDN Nepal beliefs on both upwards and downwards
  accountability for the success of each project and interventions. Thus, both upwards and
  downwards accountability will be practiced and ensured during the entire project period.
- Public/Private Partnership: The project will conduct public/private partnership for synergy building. Particularly, various service delivery agencies; livestock office, agriculture office and office of small and cottage industry will be partnered during the implementation of income generating activities such as livestock promotion, commercial vegetable farming and micro-enterprise development. In addition, partnership will be carried-out with ward offices to develop the linkage of target beneficiaries; ex-Kamaiyas, Dalits and Badi including other vulnerable groups in various skill developments trainings.

### **Overall Communication and Knowledge Management Plan:**

As communication channel refers to the process of information flow among target groups and stakeholders and also within organizational team member, Rastriya Dalit Network (RDN) Nepal will follow its **Communication Policy** which is already in place and has been updated in changing context. The project team will communicate to the project objectives, activities and achievements trough various communication channel; formal and informal as well as official and face to face. The communication and knowledge management plan of the project will target right-holders, stakeholders, civil society organizations, media and government line agencies. Both down-ward and up-ward accountability will be followed in regards to follow the project information.

Mr. Ganesh BK, central chairperson of RDN Nepal will be responsible to communicate in policy level. Particularly, he will coordinate with donor agencies, member of parliaments, respective ministries, civil society organizations and various issue-based social movements at federal level. Mr.HukumBdr. Sarki, Executive Director of the organization will be responsible to communicate at project implementation level. He will play front-line roles to communicate and coordinate with various relevant stakeholders, government line agencies and likeminded institutions at provincial and local level.

With an aim to circulate the project information, reports and data to concerned funding agencies and relevant stakeholders, various medium will be used as; email address (rdnnepal@yahoo.com) and official telephone number (+977-91-520604) -landline to deliver the formal official information such as periodic progress reports (programmatic and financial both), fund request, invitation letters etc which will be systematically documented as records for the further use as knowledge management.

The information gathered from monitoring using it as evidence of changes in the lives of target communities. The information collected under the project will be systematically documented, published and shared with funding agencies, local government bodies including other relevant stakeholders. The information will also be used as knowledge management and up scaling and replication in other development projects. The success stories/human interest stories will be produced which will be disseminated among the target beneficiaries to replicate the best







practices through possible area of collaboration.

#### **Monitoring & Evaluation:**

RDN will carry-out the Result Based Participatory Planning, Implementation, Monitoring and Evaluation (PMER) followed by its **Results Based Participatory Planning, Monitoring and Evaluation (M&E) Guideline -2018.** It will ensure the results-oriented planning, monitoring, accountability and learning as well as ensuring quality and compliances. Following are some of the practical processes/mechanisms of the participatory PMER system that will be followed in this project:

- Development of quality benchmarks (minimum standards) for all major program interventions
- Regular field monitoring visits by the PMER staff to ensure relevance, effectiveness, efficiency, sustainability, quality and compliance of project implementation
- Regular visit to the community will be set up to enable program teams to solicit feedback, complaints and grievances from the communities

In addition, review and reflection workshop will be organized on quarterly basis to reflect progress made and field level learning/challenges. The information collected under the project will be systematically documented, published and shared with funding agencies, government authorities, human right organizations, civil society organizations including other relevant stakeholders and various forums. RDN will follow the reporting template guided by the Habitat for Humanity International Nepal. In addition, it will also prepare and submit the periodic update of project progress (Monthly Update, Quarterly Progress Report, Six Months Progress Report-SMPR Annual Progress Report-APR and Project Completion Report-PCR) to the HFHI-N as required.

#### Sustainability:

**Sustainability** concern will be addressed considering several key sustainability factors such as ownership, organizational management capacity, resource creation and mobilization, coordination, linkages and networking, inclusive participation in decision making process, effective program management and implementation capacity, and need identification and planning cycle management. The key strategies and mechanisms include:


- Strategic links with local, provincial and federal government bodies
