#### 1. Context & Background:

Rastriya Dalit Network (RDN)
Nepal is the national level
Dalit organization working in
the field of Dalit rights, land
rights and Human Rights
through community
mobilization, capacity building
and evidence based
advocacy campaigns since
last 15 years. It has one Dalit
activist in each district and 45
district chapters formed and

Harawa/Charawa is the system of forceful bonded labor being practiced since the Rana era in the middle Terai of Nepal. The underlying causes of victimizing Harawa-Charawa families includes their landlessness i.e. lack of ownership of cultivable land, with combination in lack of education or vocational skills, increases their vulnerability to landowners' and/or money lenders' demands. Once a loan is taken, the landlord/ money lenders expect the borrowers and their families to provide labour indefinitely to pay off the debt. On the other hand, combination of interest rates, as high as 60% to 72% per annum, and extremely low wages resulted in years of bonded labour and even to hereditary debt.

functional. It was registered as a non-governmental organization in District Administration Office, Kailali and affiliated in Social Welfare Council in 2004. It has experience on empowerment, deepening democracy as well as social inclusion and also the practice of Dalit Parliament since the time of its establishment.

Rastriya Dalit Network (RDN) has been implementing "Network Capacity Building Project for Harawa/Charawa and their Organizations in Nepal - NCB Project" as an extended project in Saptari, Siraha and Dhanusha district of province-2 in Nepal. The duration of the project is from 1 June, 2019 to 31 May, 2019 with the financial support of Freedom Fund (FF) with an aim to support each network's development, strengthening network members' leadership for advocacy, collective bargaining and negotiation skills, enabling members to challenge all the forms of exploitation and claim their rights.

Under the implementation of the project, 3 days leadership development training was organized from 15-17 August, 2019 at Lahan Siraha. The training was focused to enhance the capacity of H-C leaders on aspects of community based organizations, network and alliance building, importance of leadership skill, institutional analysis as well as development effective communication, evidence based advocacy, campaign management and movement building.

#### 2. Objectives of the training:

- To strengthen the capacity building of Harawa Charawa leaders on leadership development, organizational development and issue based advocacy to systematically claim for their rights and entitlements
- To develop the further action plan to conduct evidence based advocacy interventions at local, district and national level for the emancipation and just rehabilitation of Harawa Charawa
- **3. Date of Training**: 15 August, 2019 to 17 August, 2019
- 4. Venue of training: Madbari Sewa Sadan, Lahan Siraha

#### 7. Process and Methodology:

The overall program was of 3 days. For the training separate schedule, detail lesson plan was prepared. Among the facilitators there were rounds of sharing and discussion was held from the very beginning to finalize the contents and facilitation tools. Even during the programs, facilitators worked as a team where supplement and compliment to each other was on the priority. Schedule enclosed in **Annex -II.** 

Similarly, for the program "Participatory" method was adopted. Emphasized was given to make sure where every participants can take part in interactions as much as possible. Under the participatory method the following tools were mainly used to facilitate the sessions:

- Brain storming
- Question/Answer
- Group work and presentation
- Game
- Experience sharing
- Role play

#### 8. Details of Leadership Development Training:

#### 15th August, 2019 (First Day)

The training was jointly inaugurated by Mr. Ganesh BK, chairperson of RDN Nepal, Mr. Bala Ram Bhattarai, consultant of Freedom Fund (FF) and Mr. Raslal Ram, general secretary of National Harawa Rights Forum. They lightened 3 candles to inaugurate the training. All the participants of the trainings including guests were warmly welcomed by Mr. Raslal Ram, general secretary of National Harawa Rights Forum. The specific objectives, agendas and importance of the training were shared by Mr. Hukum Bahadur Sarki, team leader of RDN Nepal.

On the occasion of inauguration ceremony, Mr. Ganesh BK, chairperson of RDN Nepal, Mr. Bala Ram Bhattarai, consultant of Freedom Fund (FF), Mr. Binod Bishunke, executive director of Dalit Jana Kalyan Youth Club (DJKYC) and Ms. Sarada Chaudhary, program coordinator of Shreerajpur Community Development Center (SCDC) expressed their opening remarks. The inauguration program was held in the chairpersonship of Mokasin, chairperson of District H-C rights forum, Siraha and facilitated by Mr. Sanjay Mahara, program coordinator of Rastriya Dalit Network (RDN) Nepal.

Then the formal session of the training was carried-out through the details of introduction (Name, address, representing organization, designation, likes and dislikes as well as significant changes initiated by them). The expectations of participants were focused as mentioned below;

• Strengthening Harawa Charawa networks/organizations

- Institutional Development, alliance and networking building
- Practical use and implementation of leadership development
- Tools of knowledge and evidence based advocacy at local, provincial and federal level
- Elimination of social discriminatory practices such as caste based discrimination and untouchability, gender based violence, unequal wages etc
- How to advocate for the emancipation and just rehabilitation of Harawa-Charawa?
- Common understanding of H-C leaders on advocacy agendas and their roles and responsibilities

Similarly, the role a responsibility of participants for overall reporting, evaluation, management and entertainment was also divided as mentioned below:

Himal Gaire from CMC Nepal facilitated on mental health and psycho-social problem in H-C community and role of H-C leaders for long-term solution.

Then the current emerging issues of Harawa Charawa were identified through participatory approach and prioritized based on the needs of H-C campaign. The session was facilitated by Mr. Bala Ram Bhattarai, consultant of Freedom Fund (FF).

#### Identified Issues of Harawa-Charawa

- Identity
- Education
- Employment opportunity
- Emancipation with debt alleviation
- Access and Control
- Land ownership
- Citizenship
- Housing
- Health
- Vital Registration
- Caste based discrimination and untouchability
- Fair and equal wages
- Gender based violence
- Just rehabilitation of Harawa Charawa

Among the advocacy issues mentioned above, a total of 6 issues of Harawa Charawa were prioritized as;

- Emancipation of Harawa Charawa by state with debt alleviation
- Data collection as well as verification and distribution of identity card
- Just rehabilitation of H-C with appropriate land (minimum 10 Katta of Land)
- Guarantee of education, health and employment with wages, equality and liberty
- Meaningful participation of Harawa Charawa in decision making forums
- Development and implementation of plan and policies in the presence of H-C

#### 16th August, 2019 (Second Day)

At the beginning, the first day of the training was reviewed and reflected. Mr. DB Shaha Shankar, secretary of RDN Nepal and also the resource person of training facilitated to divide the participants into four groups. The group members worked on the overall review; strengths, weakness, opportunity and challenges of Harawa Charawa campaign.

#### Overall Strengths:

- Creation of enabling environment for the emancipation of Harawa-Charawa
- Increased support and solidarity from national and international agencies
- H-C programs have been diverted towards human rights based approach (HRBA) to approach
- Increased access of H-C in financial resources by establishing and strengthening cooperatives
- Increased concern and sensitization of local, provincial and federal government on H-C issue
- Participation of H-C in different decision making forums
- Political parties and duty bearers have widely accepted the socio-economic issues of H-C and addressed in their manifestos and programs.
- Newly promulgated constitution-2015 has significant provision for the rights ex-bonded labors such as freed Haliyas, ex-Kamaiyas, Kamlharis and Harawa-Charawa

#### Weakness/Areas to be improved:

- Harawa-Charawa cannot have been emancipated yet through structural transformation of the nation
- There is no exact definition of Harawa-Charawa and their authentic data is not at hand
- There is not any formal agreement between Harawa-Charawa and government of Nepal
- H-C and their networks/organizations at local, district and national level do not have common understanding and clear agendas regarding the emancipation and just rehabilitation
- The learning of freed Haliyas and ex-Kamaiyas rehabilitation program cannot have been assimilated
- Lack of public/private resource mobilization

#### Opportunities:

- Possibility for the declaration of the emancipation of Harawa-Charawa
- H-C networks/organizations are being more functional and active
- Integrated bonded labor prohibition act is being processed
- The newly promulgated constitution of Nepal has provisioned to provide the land to Dalits once
- The federal democratic republic Nepal is under the practice of inclusive development
- Targeted programs are being implemented by government of Nepal

#### Threats/Challenges:

- Although government of Nepal at local, provincial and federal level is sensitized on the issues H-C, it has lack of willingness for the emancipation of H-C
- Common understanding of leadership on the rights and rehabilitation issue of H-C

The training session was concluded by Mr. Ganesh BK, central chairperson of Rastriya Dalit Network (RDN) Nepal. Then, Mr. DB Shah Shanker presented the overview on advocacy, campaign management and networking/alliance.

#### 17th August, 2019 (Third Day)

Mr. Ganesh BK facilitated on group, organization, leadership and leadership skill as well as types of leadership. Then, Bala Ram Bhattarai shared his views on access to justice, public service and resources as well as planning and budgeting of local government.

Finally, the action plan was developed through participatory approach to enhance the network

capacity building of Harawa-Charawa and their organizations as outlined below:

- The capacity of H-C land their networks/organizations strengthened on aspects of network and alliance building, importance of leadership skill, institutional development ,effective communication, evidence based advocacy, campaign management and movement building.
- The action plan developed to conduct evidence based advocacy campaigns at local, district and for the emancipation of H-C
