Submit the JOINT Proposal to A2J/UNDP relating to Low Value Grant to Civil Society Organizations

This Partnership Statement has been made between Rastriya Dalit Network (RDN) Nepal hereinafter referred to as First Party and SAMABESHI Foundation (SF), hereinafter referred to as Second Party with the purpose of submitting the joint proposal relating to the Low Value Grant to CSOs to implement the project on "Ensuring Access to Justice for Women and Vulnerable Groups through Legal Awareness" in four Districts of Sudurpaschim Province. Both parties are agreed to fully abide by the following points of Partnership Statement.

- 1. The First Party will submit the proposal as a main partner and Second Party will coordinate, collaborate and support to First Party in writing proposal, designing programs, implementing and reporting of project in the Province.
- 2. Both the parties are agreed to submit the proposal of amounting NPR. 3,297,000 (in words: Thirty-two Lakhs and ninety-seven thousand rupees only) including programmes, operation and overhead cost.
- 3. First Party will sign the Grant Agreement as main partner and will be responsible for the overall management of fund and programmes in effective and efficient manner and Second Party will support, collaborate, coordinate and cooperate for the same.
- 4. First Party will receive the fund on it's Bank of Kathmandu (BoK) A/C in the name of Rastriya Dalit Network (RDN) and shall transfer/deposit partial amount of the programs, operation and overhead to Second Party's official account as allocated and segregated in excel budget-sheet, at least, before 2 days of the program implementation/organization.
- 5. The budget allocation in excel budget-sheet will be expense as follows:
 - (i) Programme cost from A1 to A3 will be expense by Second Party and A4 will be expense by first party.
 - (ii) Operation cost B.1.1, B.1.2 and B.2.2 will be expense by first party and B.1.3 and B.1.4 will be expense by second party, whereas, B. 2.1 and C (overhead cost) will be expense by both parties in 50/50 percent basis.
- 6. Both the parties' organizational Logo and Name will be printed in Banner, Reports, ICE/PSA materials/publications and Attendance Sheet etc. for its visibility and cooperation spirit.
- 7. Other things/minor changes relating to the project duration, project proposal, fund amount, activities, project execution modality shall correspond to A2J project/UNDP and both the parties will have duty to abide by the A2J Project Decision.
- 8. Both the Parties maintain organizational confidentialities and code of ethics if disputes arise while implementing the programmes, both the parties will settle down it in mutual-cooperation and understanding on their own via PMC.
- 9. Both the parties will keep the financial and narrative report related to the project at least for 4 years.
