# Concept note on Community of Practice Workshop Conduct joint cross-learning sharing meeting of Harwa-Charwa, Haliya and Kamaiya Networks (Activity Code: 1.1.5)

### **Background**

ActionAid International Nepal is implementing "Ending Agriculture Bonded Labour in Nepal (EABL)" in Bardiya, Doti and Bajura Districts with partial implementation in Dang, Banke, Kailali and Kanchanpur districts. The overall goal of the project is a significant reduction in the prevalence of agricultural bonded labour in Nepal and survivors accessing sustainable freedom by receiving support for recovery and long-term resilience against exploitation. The project is also being implemented in Eastern Terai districts by the Freedom Fund, who are working with Harwa-Charwas in Saptari, Siraha and Dhanusa Districts.

Bonded labour has been traditionally implemented in Terai region and Western Hilly regions as a part of the feudalistic society. After decades and centuries of bonded labour, Kamaiyas and Haliyas started movements with support from different social organizations. After years of struggle, Kamaiyas and Haliyas were emancipated in 2058 BS and 2065 BS respectively. However, Kamlahri continued their struggles, and their emancipation was declared in 2068. Since the promulgation of Kamaiya Prohibition Act, 2002; the Kamaiyas and Haliyas issues have been identified, their data collected, and rehabilitation process is conduct but partially still ongoing. After the recent declaration by Nepal Government on Shrawan 2, 2079, the loans of Harwa-Charwas have been eliminated, but their data collection and rehabilitation is yet to start. However, the government responsibility doesn't end in the emancipation of the ex-bonded labour families as the government had committed to better livelihood opportunities, education, and health facilities for those communities.

#### Introduction

After series of meeting with federal level government and its officials, especially during May 27-28, 2022; Nepal Government cancelled all the loans of Harwa-Charwas (through 4-point declaration) on Shrawan 2, 2079 in an event organized by Ministry of Land Reformation, Cooperatives and Poverty Alleviation. This has been a landmark for the bonded labour community and the EABL project itself. However, the bonded labour communities, in support from the EABL project still need to discuss about the advocacy strategy to pressurize and support Nepal government for proper rehabilitation of Harwa-Charwas, Kamaiyas and Haliyas. Hence a joint meeting is proposed to be conducted as part of Community of Practice Workshop among bonded labour communities under activity named Conduct joint cross-learning sharing meeting of Harwa-Charwa, Haliya and Kamaiya Networks (Activity Code: 1.1.5) as proposed in the project document.

#### **Objectives**

The workshop will be organized with the following objectives:

- Target and Achievement sharing of lead partners and project implementing partners and bonded labour communities.
- Learning sharing among the bonded labour communities in the process of rehabilitation.
- Discussion on the joint movement strategy, action plan to continue the joint movement.

#### **Participants:**

Approximately 36 people from Haliya, Kamaiya and Harwa-Charwa communities (The number of participants to be confirmed in consultation with the Freedom Fund.)
